The Offer Price is expected to be fixed on or about Tuesday, 11 July 2017. Applicants are required to pay the maximum Offer Price of HK\$0.80 for each Offer Share together with 1.0% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Bookrunners (for themselves and on behalf of the Underwriters) on or before Tuesday, 11 July 2017, the Share Offer will not proceed.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
